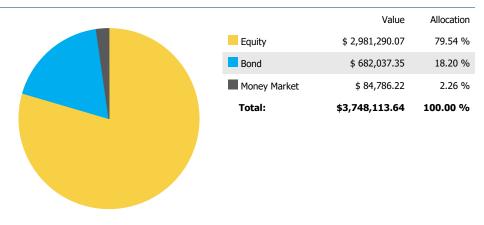

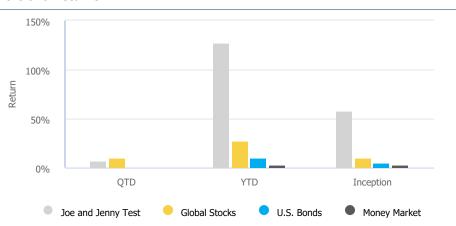
New Call Routing Options

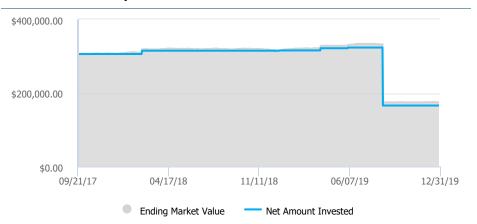

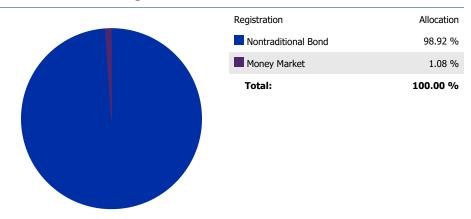

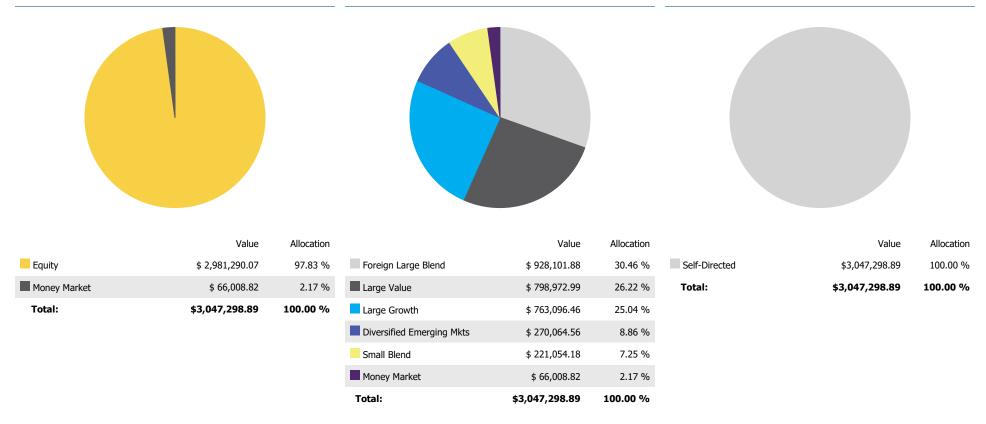

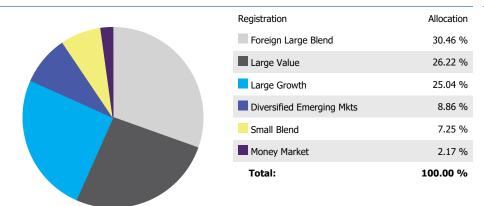

Quarterly Performance Evaluation Disclosure

The Morningstar Global Markets NR USD measures the performance of the stocks located in the developed and emerging countries across the world. Stocks in the index are weighted by their float capital, which removes corporate cross-ownership, government holdings and other locked-in shares.

The Bloomberg Barclays U.S. Aggregate Bond Index measures the performance of the total US investment-grade bond market.

The Morningstar U.S. Cash T-Bill TR includes a Treasury Bill with six to eight weeks until maturity.
